## Stock Dog Classic

### General Rules and Regulations

*Where OAS is used in the following rules, it refers to Olds Agricultural Society.*

#### General

1. **Olds Agricultural Society** is not in business for profit, and is operated for the sole purpose of aiding in the development of Agriculture and Industries of the Town and Province. Exhibitors, Concessionaires and all other persons are only admitted to the Park on the understanding that they are cooperating with OAS in the above objectives.
2. **Violation of Rules:** An exhibitor who violates any of the following rules printed in the *Prize List* shall be liable, upon the decision of the Stock Dog Committee to that effect, to the forfeiture of any and all prizes, prize money and premiums which may have been awarded to him and which have not at the time of such decision been delivered and also to the forfeiture of all privileges including passes to himself and/or his employees for such period as the Stock Dog Committee may determine and shall also be liable to forfeiture of any entry fees paid whether for classes shown before or to be shown after such violation, and also of any stall rentals or moneys paid for any privilege, and such exhibitor may be barred from showing at the Fair at which such violation occurs and for such further period as the Stock Dog Committee may determine. The Stock Dog Committee may in their discretion impose any or all of the above forfeiture and/or penalties and may impose such additional or other penalty or penalties or forfeitures as may be necessary.
3. **Liability:** All exhibitors shall be under the control and direction of OAS but solely at the risk of said exhibitor. OAS will not be responsible for damage, injury, loss or theft of or to any exhibit, irrespective of the cause of such damage, injury, loss or theft. Each exhibitor will be solely responsible for any loss, injury or damage done to, administered by or arising from any animal or article exhibited by him, for its description as given in the catalogue. This shall indemnify OAS against all legal or other proceedings in regard thereto.
4. **Exhibitor's Declaration:** An exhibitor shall, if required by the Stock Dog Committee, make a statutory declaration that the livestock exhibited are exhibited in accordance with and in all respects comply with the rules and regulations. In case any exhibitor refuses to make such declaration, all premiums awarded him shall be forfeited and all such livestock shall be removed forthwith if so ordered by the Stock Dog Committee.
5. **If required,** exhibitor must give statutory declaration as to the age of their animals.
6. **OAS reserves the right** to remove from the grounds, animals that may be deemed unsuitable or objectionable, without assigning any reason. If any exhibit has obtained admission through misrepresentation the exhibitor will forfeit any money paid for the un-expired term for space or stalls, and OAS shall be exonerated from any claim on the part of the exhibitors.
7. **An exhibitor lodging a protest** must make it in writing. It must be delivered to the Show Office on the day of the show, and receipt must be obtained. A protest must state plainly the cause of complaint or appeal and must be accompanied by a deposit of \$100.00, which shall be forfeited, to OAS if the said protest is not sustained.
8. **The Stock Dog Committee** reserves the right to decide any point not covered by the Rules.
9. **Firms and Co-Partnerships:** Firms and co-partners entering for competition must be in existence at the time of making entry and in all cases must be bonafide with affidavits of the particulars of firms available if required by the Stock Dog Committee.
10. **Advertising:** Exhibitors will not be permitted to call attention to their exhibits in a disorderly manner. Only such signs and place cards may be used throughout the facilities as the Stock Dog Committee shall approve and allow. The Stock Dog Committee reserves the right to prescribe the dimensions and regulate position of all signs, and generally to direct the arrangement of the exhibits, so far as the same may be necessary to secure harmony and an attractive appearance. Except with the permission of the Stock Dog Committee, no person will be permitted to distribute advertising matter at the event, except from his exhibit, nor tack up or post any advertisement bill, card, etc. except in the space occupied by the exhibitor.
11. **OAS will not** be responsible for any accident or injuries on OAS grounds.

### **Important Entry Information**

Every entry form must give all pertinent information requested or the entry will be returned to the Exhibitor as incomplete.

#### **Under no circumstances are telephone entries accepted.**

1. Entries must be made on official livestock entry forms. Additional forms are available upon request by contacting Olds Agricultural Society at 556-3770.
2. A fee is charged for all classes unless otherwise noted. Please refer to respective sections for specific information.
3. Exhibitors must submit all entries and actual entry information postmarked no later than June 26, 2010. Entry Fee must accompany all entries at the time of entry.
4. Exhibitors canceling their individual entries after the official closing date shall forfeit their entry fees, except on certificate of disability from a qualified veterinarian. Cancellation of animals in Group Classes will not be accepted for entry refund.
5. Entries may be faxed to 403-556-3333 accompanied by a VISA or MasterCard number and expiration date.
6. Exhibitors may enter as many animals as they desire.
7. All entries must be owned by the exhibitor upon entry closing date.

### **Diseased Animals – Health Requirements**

In maintaining a high standard of animal health, all livestock is subject to inspection on arrival and throughout the duration of the show. If evidence of an infectious or contagious disease is discovered, the owner of the infected animal shall be required to remove the said animal from the premises.

### **Judging**

1. Judges are requested to familiarize themselves with all rules and regulations of the show and especially those rules bearing on the classes judged by them.
2. Exhibitors must ascertain at what time judging will take place; and the OLDS AG SOCIETY will consider no complaint or appeal based upon the statement that the judges have overlooked exhibits. No person shall be permitted in the judging rings during the time of judging except the Directors in charge, Judges, Livestock Superintendents and their assistants, showmen of the exhibit, and members of the press.
3. If two judges working together in placing awards in any department fail to agree, they shall forthwith retire from the judging ring and the awards shall be placed by a judge, appointed by OAS whose decisions will be final.
4. Any person who shall attempt to interfere with or influence the judges while in the course of their duties, or at any time on the Fair Grounds or within the judges hearing, in consequence of any award made by them, shall forfeit his right to any prizes to which he might otherwise be entitled and may be excluded from exhibiting for one or more years thereafter. Judges are required to report any breach of this rule.
5. Judges are requested not to leave the grounds until they have ascertained from the Livestock Office that there is no protest against the awards in the section, which they judged. Judges are requested to sign all Clerk Sheets and to submit an Expense Claim Form, which is available from the Livestock Office.

### **Rules & Regulations**

1. The order of running will be determined by drawing for position by the Stock Dog Committee. Bitches in season will run last.
2. This is a timed arena trial. Timing will start when the dog is sent from the handler's side. A 20 second penalty will be assessed if the dog is sent before the signal is given.
3. Dogs may be directed by voice or whistle (Handlers may carry a stockman's cane or a shepherd's crook)
4. At least one sheep must be complete each obstacle before proceeding on to the next obstacle. Retires are the handler's choice. If the handler decides to retry the obstacle, all of the sheep must be taken back to a point prior to the obstacle with the stopwatch running. Any previous points for that obstacle are forfeited.
5. Knocking over an obstacle will result in all points lost for that obstacle.
6. The handler must remain in the handler's circle until the last sheep exits the chute. Failure to do so will result in a 20 second penalty.
7. Once the rope on the gate has been taken up by the handler, it cannot be intentionally released until the sheep are penned. Releasing the rope to gain an advantage will result in a disqualification.
8. At no time will a handler come in contact with the sheep except in the case where the sheep runs into the handler while blocking them. This includes contact with any part of the handler's body or any inanimate object. Contact with the sheep will result in disqualification.
9. Gripping and/or biting will result in disqualification.
10. If two or more handlers are equal in time and points at pen time, the tie will be broken by chute times and points. In case of incomplete runs by all competitors, positions will be determined by chute times and points.
11. Ranch entries accepted at the discretion of the committee.
12. Entries may be limited.
